11. FILING REQUIREMENTS

- (a) Copies and Address — The issuing carrier shall file 3 copies of this tender with the Illinois Commerce Commission, Transportation Division, 527 East Capitol Avenue, P.O. Box 19280, Springfield, Illinois 62794-9280.
- (b) Commencement of Transportation — Transportation subject to the terms and conditions of this tender may not commence prior to the effective date contained in Item 2. The tender must be filed on not less than 1 days notice.

- 2 (a) In Item 6, Column 1, strike out either "From" or "Between" and in Column 2, either "To" or "And".
(b) In Item 6, Column 3, place in the bracket, the application of the rate in cents or in dollars and cents per 100 pounds, per ton of 2,000 pounds, per ton of 2,240 pounds, per unit of time or other defined unit of measure.
